TIST: 2023 PROFIT SHARE PAYMENTS ARE READY

Clean Air Action Corporation (CAAC) a company that manages the TIST program is happy to announce 2023 Profit Share payments are ready to be distributed and paid to eligible Small Groups.

We are glad many Small Groups continue to abide by the Greenhouse Gas contract and the TIST values.

The GhG contract, among other requirements, asks the Small Groups to keep their trees alive for a minimum of 30 years. This is necessary to make the carbon business sustainable and profitable for the long-term.

We however, have Small Groups that have not fully understood the importance of keeping their trees alive. They cut their trees without considering the harmful effects their actions have on other farmers.

TIST tonnes continue to draw good buyers in the market. Our buyers get confidence from many farmers who continue to keep their trees alive and do other activities (co-benefits) on their farms.

In the carbon business, farmers, who are producers of the carbon tonnes, and the carbon buyers are both protected by rules governing the carbon market.

As carbon producers earn revenue from carbon tonnes sales, carbon buyers get assurance that trees will be kept alive and no carbon will be lost through harvesting.

Therefore, during payments, TIST quickly pays Small Groups that are in good standing.

This 2023 Profit Share payments intend to enhance the process of payments by making it easier and quicker.

The payments will be in two (2) major phases:

First phase: Small Groups that have met minimum criteria for Profit Share eligibility will be paid during the first phase.

There are over 9,000 Small Groups that will be paid during the first phase.

As with previous Profit Share payments, eligible Small Groups are required to do the following in order to make payments efficient, transparent and credible.

1. Upon receiving payment receipt (voucher), all members of the Small Group should append their signatures, ID numbers and their full names.
2. Small Groups should have their trusted Mobile Money custodian who will receive payments on their behalf. Mobile Money custodians should provide full names, ID numbers and Mobile Money phone numbers.
3. Your Mobile Money custodian should be a member of your Small Group and should have their trees quantified.
3. Small Groups are encouraged to attend the Cluster meetings at all times.

Second Phase: The second phase will require extra work by Small Groups working together with Cluster Servants.

Some of these Groups are missing critical information that is needed for them to be paid. Because each Small Group has unique circumstances, we will be sending specific letters detailing what they need to accomplish to qualify for payments.

EXTRA WORK YOUR SMALL GROUP MAY WORK TOGETHER WITH CLUSTER SERVANT TO FIX



1. Small Groups with less than 6 members

Your Small Group is allowed to add new members and sign a new GhG contract.

Your Cluster Servant will provide you with a new GhG contract.

Please Note: New members should come with new trees. Old trees are not allowed. They are considered as Baseline Trees.

2. Small Groups with inheritance issues

If one of the members of your Small Group has shared his land with the beneficiaries, those beneficiaries are required to commit with a letter that they are not going to harvest. This letter should be clear with full names, ID numbers, phone numbers and signatures.

3. GhG not tallying with Registration

Some Small Groups have issues with people who registered being different from people who signed the GhG contract or who get quantified.

Your Cluster Servant will work with you to fix this problem.

4. Missing Baseline information

Carbon market rules and regulations require every grove to have complete baseline information.

Some Small Groups are missing this information.

Please talk to your Cluster Servant and check if your Small Group is okay or if you need to complete baseline information.

5. Bad Tracks

When Quantifiers visit your farm, the carbon rules require they mark track boundaries of your grove. This is because, only trees within the track bound-

ary count for carbon tonnes.

Sometimes, this track is not complete or it was taken badly.

It is important you talk to your Cluster Servants to check if your groves are in good shape. If they have a problem, please ask your Cluster Servant to fix them.

6. Small Groups that have added members

Some Small Groups have added new members. These new members have not signed the GhG contract. It is a requirement of the carbon market rules that members participating in carbon credits have a contract with project companies such as CAAC.

In order to accomplish this, talk to your Cluster Servants if you have added any new members, and CS will issue you with a new contract.

Please note: It is important that old members of your Small Group give consent to admission of new members.

New members should always join with new trees (1-year-old).

REVISED CRITERIAS FOR 2023 PROFIT SHARE PAYMENTS:

SMALL PAYMENTS

Dear TIST Farmer,

In order to serve you better, TIST has revised criteria for payment for profit share 2023 and as Small Groups, you are required to help TIST management and staff have the following information collected in a correct order so that you benefit from 2023 payment.

1. Small Groups with less than 6 members



Action: TIST will pay and allow Small Groups to add new members and sign a new GhG contract. New GhG contracts should be ready in time for 2024 payments.

- Note: New members should come with new trees. Old trees are not allowed.

2. Small Groups with inheritance

Action: Affected Small Group with such cases, they will sign not to harvest and then TIST will pay if they agree.

3. GhG not tallying with Registration

Action: TIST will pay SGs that have GHG not tallying with registration, then registration issue will be fixed later.

4. Missing Baseline information

Action: If there is any missing information, TIST will ask CS to collect the missing information and, when fixed, TIST will pay the group.

- If CS fixed it, Tech team will update DB and pay the Group.

5. Bad Tracks

Action: TIST Desk Auditors will grade the tracks and when done, the group will get paid.

- If it requires CS to collect a new track, this will be fixed, and the group will get paid. Payment will proceed as CS fix the issues so that by 2024 payments are effective if all other groves meet all other criteria.

6. Small Groups that have added members

Action: TIST will pay and give them new GhG and fix it by 2024 payment.

Oku abahingi barikutunga sente za kaboni nikwe n'abaguzi baayo barikwenda ngu batungye obuhame ngu kaboni tiyaasiisikarira omukugisharuura.

Zente z'akasiimo eza 2023 zigyendereire kureeba ngu okushahura kwayanguha kandi kwaba aho-naaho.

Ekicweka ky'okubanza ni guruupu ezaahikiriize ebigyendererwa bya TIST. Omu harimu guruupu zirikurenga 9000.

1. Buri memba aratungye sente ashemereire kuta ekinkumu aha voocha, endangamuntu ye n'amaziina gye goona.
